

	The Actor Registration Module is an electronic system for the registration of the economic operators (EOs), i.e. all companies that act as / MF=Manufacturer / AR +Authorized Representative / PR=System and Procedure Pack Producer (PR) / IM=Importer It allows the creation of the unique single registration number (SRN) (see Art. 31(2)) and enables EOs to submit the necessary information such as Name, Address, Country, Contact Data.	A Single Registration Number (SRN) is a unique code that is assigned to Manufacturers, Authorised Representatives or Importers after they have registered in the European Database on Medical Devices (EUDAMED). An Actor is a natural or legal person (organisation) with a specific role that has to be registered in EUDAMED. A Local Actor Administrator (LAA) is a person appointed by every Actor to manage "Actor data" and "Actor notification email addresses" that has the power to accept request from others within Actor's organization to get access to EUDAMED. Validation Process




The Single Registration Number (SRN) identifies every Economic Operator in EUDAMED in a **unique** way.



The Economic Operator will receive a unique SRN for **EACH** Actor Role

Advantages of Early Registration

- ☐ Inclusion in relevant regulatory documentation (e.g. DoC, Technical Documentation, Certificates issued by NBs) without the need to update all later.
- ☐ The SRN guarantees an EU-wide unique identification of Economic Operators
- Registration as an Economic Operator is a **precondition** to start using the next modules of EUDAMED
